SYNOPSIS

Exempts licensed master plumbers from certain electrical contractor business permit requirements.

1 AN ACT concerning the exemption of licensed master plumbers 2 from certain electrical contractor business permit requirements 3 and amending P.L.1962 c.162. 4 5 **BE IT ENACTED** by the Senate and General Assembly of the State 6 of New Jersey: 7 8 1. Section 18 of P.L.1962, c.162 (C.45:5A-18) is amended to 9 read as follows: 10 18. Electrical work or construction which is performed on the 11 following facilities or which is by or for the following agencies 12 shall not be included within the business of electrical contracting so as to require the securing of a business permit under this act: 13 14 (a) Minor repair work such as the replacement of lamps and 15 fuses. (b) The connection of portable electrical appliances to suitable 16 17 permanently installed receptacles. 18 (c) The testing, servicing or repairing of electrical equipment or 19 apparatus. 20 (d) Electrical work in mines, on ships, railway cars, elevators, 21 escalators or automotive equipment. 22 (e) Municipal plants or any public utility as defined in R.S.48:2-23 13, organized for the purpose of constructing, maintaining and 24 operating works for the generation, supplying, transmission and 25 distribution of electricity for electric light, heat, or power. 26 (f) A public utility subject to regulation, supervision or control 27 by a federal regulatory body, or a public utility operating under the 28 authority granted by the State of New Jersey, and engaged in the 29 furnishing of communication or signal service, or both, to a public utility, or to the public, as an integral part of a communication or 30 31 signal system, and any agency associated or affiliated with any public utility and engaged in research and development in the 32 33 communications field. 34 (g) A railway utility in the exercise of its functions as a utility 35 and located in or on buildings or premises used exclusively by such 36 an agency. 37 (h) Commercial radio and television transmission equipment. 38 (i) Construction by any branch of the federal government. 39 (j) Any work with a potential of less than 10 volts. 40 (k) Repair, manufacturing and maintenance work on premises 41 occupied by a firm or corporation, and installation work on 42 premises occupied by a firm or corporation and performed by a 43 regular employee who is a Class A journeyman electrician licensed 44 pursuant to section 3 of P.L.2001, c.21 (C.45:5A-11.1).

EXPLANATION – Matter enclosed in **bold-faced** brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

1 (1) Installation, repair or maintenance performed by regular 2 employees of the State or of a municipality, county, or school 3 district on the premises or property owned or occupied by the State, 4 a municipality, county, or school district; provided that a regular 5 employee of the State, municipality, county or school district 6 performing this work is a Class A journeyman electrician licensed 7 pursuant to section 3 of P.L.2001, c.21 (C.45:5A-11.1), or holds any 8 civil service title with a job description which includes electrical 9 work pursuant to the "Civil Service Act," N.J.S.11A:1-1 et seq., or 10 regulations adopted pursuant thereto, or any employee of a State 11 authority who has completed an apprenticeship training program 12 approved by the United States Department of Labor, Bureau of 13 Apprenticeship Training, that deals specifically with electrical 14 work, and is of a minimum duration of three years.

15 Any regular employee of the State, or of a municipality, county 16 or school district who has submitted his application to the board for 17 licensure as a Class A journeyman electrician shall be permitted to 18 continue to perform work pursuant to this subsection until such time 19 as the board acts upon his application. Any applicant whose 20 licensure application is not approved by the board shall no longer 21 be permitted to perform electrical work pursuant to this subsection.

22 (m) The maintaining, installing or connecting of automatic oil, 23 gas or coal burning equipment, gasoline or diesel oil dispensing 24 equipment and the lighting in connection therewith to a supply of 25 adequate size at the load side of the distribution board, or the 26 replacement of an electric water heater with one of similar size and 27 voltage not to exceed 240 volts or less with a disconnecting means 28 at the load side of the distribution board or service disconnect 29 located within sight of the equipment, or for the replacement of a 30 service disconnect and whip serving a replacement air conditioning 31 condensing unit not exceeding 240 volts or less with one of a 32 similar size and voltage requirements.

33 (n) Work performed by a person on a dwelling that is occupied 34 solely as a residence for himself or for a member or members of his 35 immediate family.

(o) (Deleted by amendment, P.L.1997, c.305).

37 (p) Any work performed by a landscape irrigation contractor 38 which has the potential of not more than 30 volts involving the 39 installation, servicing, or maintenance of a landscape irrigation 40 system as this term is defined by section 2 of this amendatory and 41 supplementary act. Nothing in this act shall be deemed to exempt 42 work covered by this subsection from inspection required by the 43 "State Uniform Construction Code Act," P.L.1975, c.217 44 (C.52:27D-119 et seq.) or regulations adopted pursuant thereto.

45 (q) Any work performed by a person certified pursuant to 46 sections 1 through 10 of P.L.2001, c.289 (C.52:27D-25n through 47 C.52:27D-25w) that is not branch circuit wiring. For the purposes 48 of this subsection, "branch circuit wiring" means the circuit

conductors between the final overcurrent device protecting the
 circuit and one or more outlets. A certificate holder shall be
 deemed to have engaged in professional misconduct for the
 purposes of section 8 of P.L.1978, c.73 (C.45:1-21) for violating the
 provisions of this subsection.

6 (r) Any work performed by an alarm business, as that term is 7 defined by section 2 of P.L.1985, c.289 (C.45:5A-18.1), licensed 8 pursuant to P.L.1997, c.305 (C.45:5A-23 et seq.) that is not branch 9 circuit wiring. For the purposes of this subsection, "branch circuit 10 wiring" means the circuit conductors between the final overcurrent 11 device protecting the circuit and one or more outlets. A licensee 12 shall be deemed to have engaged in professional misconduct for the 13 purposes of section 8 of P.L.1978, c.73 (C.45:1-21) for violating the 14 provisions of this subsection.

The board may also exempt from the business permit provisions of this act such other electrical activities of like character which in the board's opinion warrant exclusion from the provisions of this act.

STATEMENT

28 This bill exempts licensed master plumbers in the State from 29 certain business permit requirements under the law governing electrical contractors concerning certain electric water heaters and 30 31 air conditioning units. Electric water heaters are among the most 32 common types of water heaters in New Jersey and the United 33 States, and are increasing in popularity due to their cost and energy 34 efficiency. Electric air conditioning condensing units are also very 35 popular appliances.

36 Licensed master plumbers in New Jersey possess the skills and 37 training necessary to replace these appliances, but under current law 38 these plumbers would need to hold a New Jersey master 39 electrician's license to perform such work. By exempting licensed 40 New Jersey master plumbers from needing a business permit from 41 the Board of Examiners of Electrical Contractors, this bill frees 42 those plumbers to perform additional tasks. This less burdensome 43 requirement will provide costs savings to customers by increasing 44 competition for plumbing services and plumbers by removing a 45 costly and unnecessary regulatory requirement.
